## **Lux Products "GO LUXPRO" Promotion**

### **Official Rules and Regulations**

These rules and regulations ("Official Rules") apply to the "GO LUX PRO" including all of the contests described below ("Promotion"), being conducted by LUX Products, 880 Louis Drive, Warminster, PA 18974, and its affiliates and subsidiaries (collectively, "Sponsor"). To qualify, alternate entries must be postmarked by October 31, 2008 and received by November 5, 2007. Only one entry per postmarked envelope will be accepted. Use of any automated system to participate is prohibited and will result in disqualification. Entries become the property of Sponsor and will not be returned.
